This has reference to your application No.SG/2006-07, dated 1 th April, 2007 for affiliation of a new college for Bachelor of Education (B.Ed.), proposed to be started at Katemanivli, Kalyan (E), from the academic year 2007-08.

In this connection, I am directed to inform you that considering the permission granted by the Government of Maharashtra to your Society as per the letter eferred to above, the Academic Council at its meeting held on 12th June, 2007 vide item No.3.49 has granted the permission for first time affiliation to start a new college of Education imparting B.Ed. degree course at Kalemanivli, Ralyan (E), on permanently 'No Grant Basis' for a period of one year for the academic year 2007-08 subject to the condition that the college authorities give an undertaking in writing that they will fulfill the conditions mentioned in the LIC report to the satisfaction of the Academic Council.

The college has to fulfill the conditions mentioned in the letter under reference, issued by the Regional Director, National Council for Teacher Education Bhopal.

The college has also to fulfill the following affiliation conditions -

- (I) that the conditions laid down by the University from time to time.
- (2) that the minimum attendance of all the students must not be less than 75% during the academic year and college will have to complete syllabus of all the subjects during the academic year.
- (2) Admissions should not be linked with donations.
- that they will strictly follow the Ordinance 2802 in respect of preventing the colleges and Management of Colleges from accepting conation or capitation fees for admission of students in the Colleges, quoted in the University Circular No.Aff./Recog./49 of 1987, dated 4th February, 1987 (copy enclosed.)
